Permits

The 2010 High Productivity Motor Vehicle (HPMV) amendment to the Vehicle Dimensions and Mass (VDAM) rule enables heavy vehicles to operate under permit at weights above the standard legal maximum (typically 44 tonnes) on specific routes where the road network is capable.



whether the permit is for an Over Length (OL), 50MAX, or HPMV.

A **50MAX permit** is only issued to a combination of 9 axles which is designed and built to approved NZTA regulations. HPMV is for any combination that exceeds the VDAM rule. A truck and trailer unit over 20m will require an OL permit and must not exceed 23m. Any tractor unit and semi-trailer over 19m requires an OL permit and must not exceed 19.45m.

When applying for a **50MAX** or **HPMV permit**, vehicle combination checks also take place along with operator compliance checks. The application process is carried out online and dependant on **50MAX** or **HPMV** will involve supplying an attribute sheet (spec sheet supplied by an engineer only), line drawings, and at times, additional vehicle information. This can take 5-7 days for a 50MAX and 4-6 weeks (sometimes more) for an HPMV permit. A HPMV or 50MAX permit will have an expiry which is normally a maximum of 2 years from date of issue.



HPMV/50MAX approved roads are increasing all the time with updates available through the NZTA website.



The NZTA views all permits as a privilege and not a right.



This is an example of a non-pro-forma unit that has been trialled in conjunction with the NZTA. It is carting pulp and timber between Pan Pac in Whirinaki and the Ports of Napier with a 62 ton gross.
